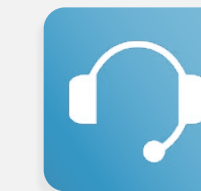
Each backup is then synchronised to a second cloud location to add a further layer of redundancy. Backups can also be retained on-site if required.

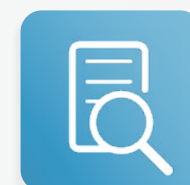

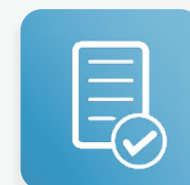

A broad range of add-on modules protect all your data assets, including: VMware, Hyper-V, Microsoft Exchange Server, Microsoft SQL Server, Oracle Database, MySQL Database, Lotus Domino, Lotus Notes, Windows System, Windows System State (Active Directory), Office 365 Exchange Mailbox and Files.

Enhanced Security

All data is AES256 encrypted before being sent over SSL to the cloud. This double encryption prevents theft or leaks while the data is in transit or stored in Ekco's secure data centres.

Multiple Backup Options

Ekco Cloud Backup supports full, incremental, differential, synthetic and mirrored backup configurations. This gives you complete control of your backups and accelerates recovery of your data.

Periodic Testing

To ensure your backup is functioning reliably, Ekco's experienced data management experts will work with you to conduct periodic testing. They will also optimise settings and routines to prevent loss and speed up recovery operations.

Granular/File Level Restore

All data stored in the cloud is protected against accidental deletion. This ensures your backups are always accurate and complete and that you meet your compliance obligations.

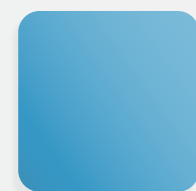
